The child suffered a fractured skull, broken ribs and other injuries as a result of an encounter with police in a park in July 2011. An expert hired by the child's mother says the officers struck the child with a baton or a wooden stick, knocking him unconscious. The child's grandmother is asking the court to order the officers to pay damages for his medical bills. But attorneys for the officers argue that if the plaintiffs prevail, officers would be sued multiple times for every injury that a child suffers. "Every time there's a lawsuit filed, it's just added potential liability for those officers," Orlando attorney Beth Spector,

who represents the officers, told ABCNews.com. Lawyer Charles Burris, who represents the child's mother, told the Orlando Sentinel that the officers should not be shielded from liability if they were negligent because the city is responsible for failing to give them proper training. "The way our law is set up, we may protect the police from being sued in our city, but we also say 'You're liable for any damages that your negligence causes'," he told the paper. The child's mother and grandfather filed the case in Orange County on the grounds that the child was 3 when he was taken into custody and the officers took him from his mother despite her objection that he was only 2. The mother's attorney accuses the officers of excessive force. The mother had been driving through Orlando when she was stopped at a red light, records show. After she was pulled over, the Orlando police report says the woman ran. She was taken by officers into custody and told she would be charged with resisting arrest, records show. The child was taken from the scene and placed in the back of an officer's patrol car. "The defendant officers removed the minor child from the scene and took the minor child to 6d1f23a050
