Understand the depreciation rules for depreciation expenses and depreciation deductions. Your Depreciation Table is the place to record all depreciation expenses. An expense is a transaction if the expense meets the requirements for what constitutes a transaction. For example, costs of transportation for independent contractors and loss of trade are business expenses. For more information on what constitutes a transaction, see Transactions in Regard to the Definition of Expense in Regulation Section 1.263(a)-1(a)(1). The regulations require that no depreciation expense be allowed for a period that exceeds 50 percent of the depreciation life of the asset. Under this provision, the depreciation period of an asset used by an individual in the production of income ends 50 percent of the time the asset is used. For example, an asset that has a depreciation life of three years is used for 50 percent of the depreciation period, and therefore, is depreciated for one year. The accounting treatment, however, may require that all depreciation expenses be capitalized. If an asset used in the production of income is first put into service after December 31, 1984, the asset should have a period of depreciation and a residual amount that is capitalized. All depreciation expenses that were capitalized must be expensed or amortized over the portion of the depreciation period that was not already capitalized. In addition, a portion of the residual value or amortizable balance must be revalued at least once a year using the straight-line method. This provision allows a taxpayer to elect, at its election, to depreciate an asset over the depreciation life of the asset and the residual value. Any residual value that is depreciated cannot be used to reduce ordinary income. For more information on depreciation and recovery, see Reg. section

1.167(a)-9(c). Treatment of Depreciation Expenses. An asset used in the production of income is a capital asset. An asset must be depreciable to be eligible for the Depreciation section of your books and records.

The main contribution of this work is the relationship between a crack's size and the crack density. Instead of using raw pixel information, our results demonstrate that crack density can be used to model and analyze a crack's size. We found that it is possible to detect and predict the size of a crack. For this reason, we demonstrated that a numerical method can be used to predict and model the size of the cracks on the pavement. We also used some of the techniques from this work to detect and model cracks.
